The global casinos & gaming sector had a total gross gaming win of \$393.4 billion in 2022, representing a compound annual growth rate (CAGR) of 3.3% between 2017 and 2022.

The casinos segment accounted for the sector's largest proportion in 2022, with a total gross gaming win of \$147.7 billion, equivalent to 37.6% of the sector's overall value.



The huge popularity of online gaming, providing immersive experiences to the user, has become famous among the young generation, propelling sector growth.
