The global chemicals market had total revenues of \$4,739.1 billion in 2021, representing a compound annual growth rate (CAGR) of 2.7% between 2016 and 2021.

The commodity chemicals segment accounted for the largest proportion of the market in 2021, with total revenues of \$2,377.0 billion, equivalent to 50.2% of the market's overall value.

The Asia-Pacific region is the largest globally and had a 59.2% share of the global chemicals market's total value in 2021, the majority of which (64.3%) is accounted for by China.
