The global investment banking & brokerage sector had total revenues of \$65.7bn in 2016, representing a compound annual rate of change (CARC) of -0.6% between 2012 and 2016.

The bonds segment was the sector's most lucrative in 2016, with total revenues of \$27.3bn, equivalent to 41.6% of the sector's overall value.

Suppressed fees contributed to a poor 2016 for the sector. Overall, investment banking fees fell 7% globally in 2016, dragged down by a 23% drop in equity capital market fees.

Ring-fencing investment banks from retail banks will change relationships in the banking industry as a whole.

Financial services is largely controlled by the leading investment banks which offer an extensive range of services, providing a 'one-stop-shop' for financial products tailored to end-users who require investment banking services.
