#### Summary

Market values reflect revenues generated through fees and commissions obtained in three key segments: M&A advisory, equity underwriting, and bonds.

The global investment banking & brokerage sector recorded revenues of \$79.1 billion in 2023, representing a compound annual growth rate (CAGR) of 1.5% between 2018 and 2023.

The bonds segment accounted for the sector's largest proportion in 2023, with total revenues of \$35.9 billion, equivalent to 45.3% of the sector's overall value.

Asia-Pacific accounting for a share of 67.16%, was the largest investment



banking and brokerage sector globally, followed by Europe at 21.1%, and Japan at 4.7% in 2023.
