The jewelry & watches segment accounted for the market's largest proportion in 2023, with total revenues of \$4,44,057.3 million, equivalent to 68.7% of the market's overall value.

In 2023, the global jewelry & watch retail market saw a 2.9% annual growth, driven by factors such as decreasing unemployment, improved living standards, and a rising consumer confidence index, all contributing to the market's

expansion.
