#### **SUMMARY**

Global MVNOs industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). The MVNO (mobile virtual network operator) market is defined as revenues generated by a wireless or cellular telecommunication service company that does not own the wireless network infrastructure. Revenues are based on the total mobile market value using the MVNO subscription share of the total mobile subscriptions.

The global MVNOs sector had total revenues of \$54.6bn in 2021, representing a compound annual growth rate (CAGR) of 4.1% between 2016 and 2021.

Sector consumption volume increased with a CAGR of 12.3% between 2016 and 2021, to reach a total of 324.1 million subscribers in 2021.

The global MVNO sector has experienced moderate growth during the historic period, with its value increasing by 2.5% in 2021.
