SUMMARY

Global MVNOs industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-22, and forecast to 2027). KEY HIGHLIGHTS

The MVNO (mobile virtual network operator) market is defined as revenues generated and owned by a wireless or cellular telecommunication service company that does not own the wireless network infrastructure. Revenues are based on the total mobile market value using the MVNO subscription share of the total mobile subscriptions.

The global MVNOs sector had total revenues of \$46.3 billion in 2022, representing a negative compound annual growth rate (CAGR) of 1.1% between 2017 and 2022.

Sector consumption volumes declined with a CAGR of 5.4% between 2017 and 2022, to reach a total of 305.5 million subscribers in 2022.

The sector players are implementing strategies to enter new markets and capitalize on the growing opportunities and expand their customer base.
