SUMMARY

Global Tobacco industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2013-17, and forecast to 2022). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The tobacco market consists of the retail sale of cigarettes, cigars and cigarillos, smokeless tobacco, and smoking tobacco. The cigarettes segment consists of filter cigarettes and plain cigarettes. The cigars and cigarillos segment comprises large cigars and small cigars. Similarly, the smokeless tobacco segment consists of pipe tobacco and fine cut tobacco (FCT) and the smoking tobacco segment includes snuff/snus and chewing tobacco products. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2017 exchange rates.

The global tobacco market had total revenues of \$609.6bn in 2017, representing a compound annual growth rate (CAGR) of 1.5% between 2013 and 2017.

Market consumption volume declined with a compound annual rate of change (CARC) of -1.8% between 2013 and 2017, to reach a total of 4,603.7 billion pieces in 2017.



Several socio-economic challenges, such as stringent government policies, rising health consciousness, the increasing popularity of substitutes, and an economic slowdown largely affected the global tobacco market during the review period.
