The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The government spending industry within the NAFTA countries had a total market value of \$10,669.9 billion in 2023. The Mexico was the fastest growing country, with a CAGR of 11.8% over the 2019-23 period.

Within the government spending industry, the US is the leading country among the NAFTA bloc, with market revenues of \$9,332.0 billion in 2023. This was followed by Canada and Mexico, with a value of \$804.2 and \$533.6 billion, respectively.

The US is expected to lead the government spending industry in the NAFTA bloc, with a value of \$11,797.3 billion in 2028, followed by Canada and Mexico with expected values of \$1,130.3 and \$802.0 billion, respectively.
