Groupe Steria SCA (Steria or 'the company') is an information technology (IT) services provider engaged in offering end-to-end IT enabled business services to private and public organizations. The company's services include consulting, digital expertise, as well as optimized infrastructures, applications and business process services. It is headquartered in Issy-les-Moulineaux, France and employed 20,293 people as of December 31, 2013.

The company recorded revenues of E1,754.9 million (\$2,330.5 million) during the financial year ended December 2013 (FY2013), a decrease of 4% compared to FY2012. The operating profit of the company was E53.8 million (\$71.5 million) in FY2013, a decrease of 39.1% compared to FY2012. Its net profit was E8.9 million (\$11.8 million) in FY2013, a decrease of 78.4% compared to FY2012.
