The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The gyms, health & fitness clubs industry within the NAFTA countries had a total market value of \$24,903.5 million in 2017. The Mexico was the fastest growing country, with a CAGR of 17.3% over the 2013-17 period.

Within the gyms, health & fitness clubs industry, the US is the leading country among the NAFTA bloc, with market revenues of \$21,290.8 million in 2017. This was followed by Canada and Mexico, with a value of \$2,022.4 and \$1,590.3 million, respectively.



The US is expected to lead the gyms, health & fitness clubs industry in the NAFTA bloc, with a value of \$24,357.6 million in 2022, followed by Mexico and Canada with expected values of \$2,954.4 and \$2,342.7 million, respectively.
