The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The gyms, health & fitness clubs industry within the NAFTA countries had a total market value of \$38.8 billion in 2022. The Canada was the fastest growing country, with a CAGR of 16.1% over the 2018-22 period.

Within the gyms, health & fitness clubs industry, the US is the leading country among the NAFTA bloc, with market revenues of \$30.5 billion in 2022. This was followed by Canada and Mexico, with a value of \$6.2 and \$2.1 billion, respectively.

The US is expected to lead the gyms, health & fitness clubs industry in the NAFTA bloc, with a value of \$41.9 billion in 2027, followed by Canada and Mexico with expected values of \$8.5 and \$3.1 billion, respectively.
