Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The haircare industry within the NAFTA countries had a total market value of \$17,627.6 million in 2023. The US was the fastest growing country, with a CAGR of 6.9% over the 2019-23 period.

Within the haircare industry, the US is the leading country among the NAFTA bloc, with market revenues of \$13,759.0 million in 2023. This was followed by Mexico and Canada, with a value of \$2,571.1 and \$1,297.5 million, respectively.

The US is expected to lead the haircare industry in the NAFTA bloc, with a value of \$17,387.1 million in 2028, followed by Mexico and Canada with expected values of \$3,453.2 and \$1,510.1 million, respectively.
