The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The hair care industry within the NAFTA countries had a total market value of \$16,920.4 million in 2018. The Mexico was the fastest growing country, with a CAGR of 6.9% over the 2014-18 period.

Within the hair care industry, the US is the leading country among the NAFTA bloc, with market revenues of \$13,117.7 million in 2018. This was followed by Mexico and Canada, with a value of \$2,268.8 and \$1,533.9 million, respectively.

The US is expected to lead the hair care industry in the NAFTA bloc, with a value of \$15,361.1 million in 2023, followed by Mexico and Canada with expected values of \$2,750.6 and \$1,728.9 million, respectively.
