The US health care equipment & supplies market had total revenues of \$173,621.5m in 2020, representing a compound annual growth rate (CAGR) of 2.7% between 2016 and 2020.

The disposable equipment & supplies segment was the market's most successful in 2020, with total revenues of \$66,253.9m, equivalent to 38.2% of the market's overall value.

Recently in the US, there has been a rise in demand for minimally invasive surgeries, which has aided the growth of the market for medical device suppliers.
