Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the healthcare providers industry and had a total market value of \$1,698.3 billion in 2023. Brazil was the fastest growing country with a CAGR of 10.5% over the 2019-23 period.

Within the healthcare providers industry, China is the leading country among the BRIC nations with market revenues of \$1,283.0 billion in 2023. This was followed by Brazil, India and Russia with a value of \$250.7, \$85.8, and \$78.8 billion, respectively.

China is expected to lead the healthcare providers industry in the BRIC nations with a value of \$1,820.5 billion in 2028, followed by Brazil, India, Russia with expected values of \$308.3, \$113.7 and \$77.8 billion, respectively.
