Within the healthcare providers industry, China is the leading country among the BRIC nations with market revenues of \$1,106.1 billion in 2020. This was followed by Brazil, India and Russia with a value of \$222.1, \$115.5, and \$91.8 billion, respectively.

China is expected to lead the healthcare providers industry in the BRIC nations with a value of \$2,024.3 billion in 2025, followed by Brazil, India, Russia with expected values of \$318.8, \$205.3 and \$136.3 billion, respectively.
