Key Highlights

The G8 countries contributed \$6,754.9 billion in 2023 to the global healthcare providers industry, with a compound annual growth rate (CAGR) of 4.7% between 2019 and 2023. The G8 countries are expected to reach a value of \$8,936.6 billion in 2028, with a CAGR of 5.8% over the 2023-28 period.

Among the G8 nations, the US is the leading country in the healthcare providers industry, with market revenues of \$4,433.4 billion in 2023. This was followed by Germany and Japan, with a value of \$557.5 and \$473.4 billion, respectively.

The US is expected to lead the healthcare providers industry in the G8 nations with a value of \$5,806.9 billion in 2016, followed by Germany and Japan with expected values of \$746.9 and \$629.8 billion, respectively.
