### SUMMARY

The G8 countries contributed \$6,019.4 billion in 2020 to the global healthcare providers industry, with a compound annual growth rate (CAGR) of 4.2% between 2016 and 2020. The G8 countries are expected to reach a value of \$7,593.7 billion in 2025, with a CAGR of 4.8% over the 2020-25 period.

Among the G8 nations, the US is the leading country in the healthcare providers industry, with market revenues of \$3,823.6 billion in 2020. This was followed by Japan and Germany, with a value of \$604.0 and \$478.8 billion, respectively.

The US is expected to lead the healthcare providers industry in the G8 nations with a value of \$4,999.4 billion in 2016, followed by Japan and Germany with expected values of \$654.3 and \$591.5 billion, respectively.
