The outpatient care segment accounted for the market's largest proportion in 2024, with total revenues of \$641.8 million, equivalent to 48.9% of the market's overall value.

The growth of the Chinese healthcare providers market is driven by the country's mounting aging population, with a high prevalence of chronic diseases such as hypertension, diabetes, and cardiovascular conditions.



According to the State Council of the People's Republic of China, at the end of 2023 (the latest available data), China had 297 million people aged 60 or above, constituting 21.1% of the total population.
