SUMMARY

The Dutch healthcare providers sector had total revenues of \$95.1bn in 2020, representing a compound annual growth rate (CAGR) of 3.5% between 2016 and 2020.

The outpatient care segment was the sector's most lucrative in 2020, with total revenues of \$25.9bn, equivalent to 27.2% of the sector's overall value.

A major factor constraining growth in the sector is the prevalence of the generics market, creating less-favourable conditions for manufacturers of more expensive branded drugs.
