### **Key Highlights**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The healthcare providers industry within the NAFTA countries had a total market value of \$4,784.0 billion in 2023. The Mexico was the fastest growing country, with a CAGR of 10.2% over the 2019-23 period.

Within the healthcare providers industry, the US is the leading country among the NAFTA bloc, with market revenues of \$4,433.4 billion in 2023. This was followed by Canada and Mexico, with a value of \$254.8 and \$95.8 billion, respectively.

The US is expected to lead the healthcare providers industry in the NAFTA bloc, with a value of \$5,806.9 billion in 2028, followed by Canada and Mexico with expected values of \$359.9 and \$132.0 billion, respectively.
