The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The healthcare providers industry within the NAFTA countries had a total market value of \$4,089.7 billion in 2020. The Mexico was the fastest growing country, with a CAGR of 5.9% over the 2016-20 period.

Within the healthcare providers industry, the US is the leading country among the NAFTA bloc, with market revenues of \$3,823.6 billion in 2020. This was followed by Canada and Mexico, with a value of \$207.4 and \$58.7 billion, respectively.

The US is expected to lead the healthcare providers industry in the NAFTA bloc, with a value of \$4,999.4 billion in 2025, followed by Canada and Mexico with



expected values of \$272.2 and \$84.9 billion, respectively.
