### Summary

These countries contributed \$1,739.0 billion to the global healthcare providers industry in 2023, with a compound annual growth rate (CAGR) of 7.9% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$2,401.1 billion in 2028, with a CAGR of 6.7% over the 2023-28 period.

Within the healthcare providers industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,283.0 billion in 2023. This was followed by Brazil and Mexico with a value of \$250.7 and \$95.8 billion, respectively.

China is expected to lead the healthcare providers industry in the top five emerging nations, with a value of \$1,820.5 billion in 2028, followed by Brazil and Mexico with expected values of \$308.3 and \$132.0 billion, respectively.
