The G8 countries contributed \$5,897.0 billion in 2019 to the global healthcare providers industry, with a compound annual growth rate (CAGR) of 3.9% between 2015 and 2019. The G8 countries are expected to reach a value of \$7,841.2 billion in 2024, with a CAGR of 5.9% over the 2019-24 period.

Among the G8 nations, the US is the leading country in the healthcare providers industry, with market revenues of \$3,824.8 billion in 2019. This was followed by Japan and Germany, with a value of \$569.7 and \$455.0 billion, respectively.

The US is expected to lead the healthcare providers industry in the G8 nations with a value of \$5,513.8 billion in 2016, followed by Japan and Germany with

expected values of \$599.2 and \$551.6 billion, respectively.
