The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The healthcare providers industry within the NAFTA countries had a total market value of \$4,085.0 billion in 2019. The Mexico was the fastest growing country, with a CAGR of 5.1% over the 2015-19 period.

Within the healthcare providers industry, the US is the leading country among the NAFTA bloc, with market revenues of \$3,824.8 billion in 2019. This was followed by Canada and Mexico, with a value of \$199.3 and \$60.9 billion, respectively.



The US is expected to lead the healthcare providers industry in the NAFTA bloc, with a value of \$5,513.8 billion in 2024, followed by Canada and Mexico with expected values of \$251.7 and \$77.8 billion, respectively.
