These countries contributed \$1,380.3 billion to the global healthcare providers industry in 2019, with a compound annual growth rate (CAGR) of 11.1% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$2,164.6 billion in 2024, with a CAGR of 9.4% over the 2019-24 period.

Within the healthcare providers industry, China is the leading country among the top 5 emerging nations, with market revenues of \$969.5 billion in 2019. This was followed by Brazil and India with a value of \$217.0 and \$101.6 billion, respectively.

China is expected to lead the healthcare providers industry in the top five



emerging nations, with a value of \$1,646.6 billion in 2024, followed by Brazil and India with expected values of \$262.8 and \$136.2 billion, respectively.
