It operates mines and plants through Khetri Copper Complex, Indian Copper Complex, Malanjkhand Copper Project, Taloja Copper Project, and Gujarat Copper Project. The company operates ICC at Ghatsila, Jharkhand; KCC at Khetrinagar, Rajasthan; MCP at Malanjkhand, Madhya Pradesh; TCP at Taloja, Maharashtra; and



GCP at Jhagadia, Gujarat. HCL is headquartered in Kolkata, West Bengal, India.
