The bank credit segment accounted for the industry group's largest proportion in 2022, with total assets of \$1,378.8 billion, equivalent to 38.8% of the industry group's overall value.

The Hong Kongese banks industry group has expanded recently owing to several factors, such as a robust regulatory framework, increasing interest rates, and a highly skilled labor population. Additionally, the number of new



households, which often require mortgages, mostly from banks, grew by over 25,000 in 2022, according to GlobalData.
