The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The hot drinks industry within the NAFTA countries had a total market value of \$25,152.4 million in 2017. The Mexico was the fastest growing country, with a CAGR of 7.4% over the 2013-17 period.

Within the hot drinks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$18,775.4 million in 2017. This was followed by Canada and Mexico, with a value of \$4,324.6 and \$2,052.4 million, respectively.

The US is expected to lead the hot drinks industry in the NAFTA bloc, with a value of \$24,257.2 million in 2022, followed by Canada and Mexico with expected values of \$5,922.1 and \$2,749.0 million, respectively.
