The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The hot drinks industry within the NAFTA countries had a total market value of \$21,332.8 million in 2015. The US was the fastest growing country, with a CAGR of 10.4% over the 2011-15 period.

Within the hot drinks industry, the US is the leading country among the NAFTA bloc, with market revenues of \$15,609.3 million in 2015. This was followed by Canada and Mexico, with a value of \$3,528.0 and \$2,195.6 million, respectively.

The US is expected to lead the hot drinks industry in the NAFTA bloc, with a value of \$24,522.0 million in 2020, followed by Canada and Mexico with expected values of \$4,712.2 and \$2,673.1 million, respectively.
