The Indian IT services industry is expected to generate total revenues of \$50.8billion in 2022, representing a compound annual growth rate (CAGR) of 11.1% between 2017 and 2022.

The infrastructure services segment is expected to be the industry's most lucrative in 2022, with total revenues of \$29.3 billion, equivalent to 57.6% of the industry's overall value.

The ICT industry and the Digital Economy are two of India's main economic



drivers, accounting for over 13% of its gross domestic product (GDP). ICT spending in India is expected to reach \$1 trillion by 2025, or 20% of GDP.
