The total value of the market represents the demand for the service coming from a particular country.

The Indonesian BPO services market had total revenues of \$1,624.3 million in 2021, representing a compound annual growth rate (CAGR) of 5.6% between 2016 and 2021.

The vertical-specific BPO segment was the market's most lucrative in 2021, with total revenues of \$420.3 million, equivalent to 25.9% of the market's overall

value.

Indonesia is one of the fastest growing internet economies which is expected to turn the country as one of the attractive destinations for outsourcing.
