The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Indonesian BPO services market had total revenues of \$2.6 billion in 2022, representing a compound annual growth rate (CAGR) of 7% between 2017 and 2022.

The HR outsourcing segment accounted for the market's largest proportion in 2022, with total revenues of \$0.7 billion, equivalent to 25.9% of the market's overall value.

Indonesia offers a competitive business environment with a proficient workforce possessing digital and software skills. Also, the country has significantly low labor costs as compared to several other Asia-Pacific countries. These factors encourage the demand for outsourcing to Indonesia.
