Summary

The Indonesian chemicals market had total revenues of \$39.4 billion in 2023, representing a compound annual growth rate (CAGR) of 0.4% between 2018 and 2023.

The commodity chemicals segment accounted for the market's largest proportion in 2023, with total revenues of \$26 billion, equivalent to 66.1% of the market's overall value.

The Indonesian chemicals market is impacted by macroeconomic factors such as GDP growth and industrial production. According to data from the Indonesian Ministry of Industry (Kemenperin), as of 2023, exports of processed chemicals

from Indonesia reached \$20 billion, while imports amounted to \$27.8 billion.
