SUMMARY

The BRIC Insurance Brokers industry profile provides top-line qualitative and quantitative summary information including: market size (value 2012-16, and forecast to 2021). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the insurance brokers industry and had a total market value of \$2.0 billion in 2016. China was the fastest growing country with a CAGR of 16.2% over the 2012-16 period.

Within the insurance brokers industry, China is the leading country among the BRIC nations with market revenues of \$0.8 billion in 2016. This was followed by Brazil, Russia and India with a value of \$0.5, \$0.4, and \$0.3 billion, respectively.

China is expected to lead the insurance brokers industry in the BRIC nations with a value of \$1.2 billion in 2021, followed by Brazil, Russia, India with expected values of \$0.7, \$0.5 and \$0.5 billion, respectively.
