SUMMARY

Insurance Brokers in Europe industry profile provides top-line qualitative and quantitative summary information including: market size (value 2014-18, and forecast to 2023). KEY HIGHLIGHTS

The insurance brokers market is valued in relation to the total brokerage revenue of non-life insurance and reinsurance brokerage firms. All currency conversions have been carried out at constant annual average 2018 exchange rates.

The European insurance brokers sector had total revenues of \$6.9bn in 2018, representing a compound annual growth rate (CAGR) of 1.1% between 2014 and 2018.

The primary insurance segment was the most lucrative sector in 2018, with total revenues of \$5.3bn, equivalent to 77.6% of the sector's overall value.

High Insurance Premium Tax, evident in the UK and Germany, can damage earnings in the brokerage sector as they reduce pricing flexibility and thus the broker often has to bear the majority of the costs.
