### SUMMARY

The life insurance and pension segment was the sector's most lucrative in 2020, with total revenues of \$0.2bn, equivalent to 67.1% of the sector's overall value.

The value of the French insurance brokers sector declined by 10% in 2020, as a result of the COVID-19 pandemic, which reduced demand for insurance products.
