### SUMMARY

The general insurance segment was the sector's most lucrative in 2020, with total revenues of \$0.1bn, equivalent to 55.4% of the sector's overall value.

The value of the German insurance brokers sector grew by 0.1% in 2020, demonstrating resilience during the COVID-19 pandemic, which reduced demand for insurance products.
