Insurance Brokers in Germany

SUMMARY

Insurance Brokers in Germany industry profile provides top-line qualitative and quantitative summary information including: market size (value 2014-18, and forecast to 2023). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The insurance brokers market is valued in relation to the total brokerage revenue of non-life insurance and reinsurance brokerage firms. All currency conversions have been carried out at constant annual average 2018 exchange rates.

The German insurance brokers sector had total revenues of \$1.6bn in 2018, representing a compound annual growth rate (CAGR) of 0.9% between 2014 and 2018.

The primary insurance segment was the most lucrative sector in 2018, with total revenues of \$1.3bn, equivalent to 80% of the sector's overall value.

German new car industry volume fell by 0.2% and its value only saw weak growth. A decline in this industry can be damaging to the insurance brokers sector.
