SUMMARY

KEY HIGHLIGHTS

The insurance brokers sector is valued in relation to the total brokerage revenue of non-life insurance and reinsurance brokerage firms. All currency conversions have been carried out at constant annual average 2016 exchange rates.

The South African insurance brokers sector had total revenues of \$109.6m in 2016, representing a compound annual growth rate (CAGR) of 7.3% between 2012 and 2016.

The primary insurance segment was the sector's most lucrative in 2016, with total revenues of \$94.9m, equivalent to 86.6% of the sector's overall value. The reinsurance segment contributed revenues of \$14.7m in 2016, equating to



13.4% of the sector's aggregate value.

The South African economic turmoil in the last three years had a decelerating growth impact on the insurance brokers sector in the country. In fact, the depreciation of rand together with rising inflation, are undermining the revenues of brokers as fees are fixed by regulation for short-term insurance such as motor vehicle insurance products.
