SUMMARY

The insurance market consists of the non-life and life insurance sectors. The value of the market is shown in terms of gross premium incomes.

The German insurance market had total gross written premiums of \$258.3bn in 2020, representing a compound annual growth rate (CAGR) of 4.4% between 2016 and 2020.

The non-life Insurance segment was the market's most lucrative in 2020, with total gross written premiums of \$151.9bn, equivalent to 58.8% of the market's overall value.

Growth in the German insurance market has been supported by the uptake of new technology by insurance companies, a trend which is likely to continue across the forecast period as consumer preferences and demands continue to evolve.
