Summary

Internet Access in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2016-20, and forecast to 2025). Key Highlights

The internet access sector consists of the total Internet Service Revenue charged for the provision of narrowband and broadband Internet connections through both consumer and corporate channels. All revenues calculated are retail revenues exclusive of taxes.

The Scandinavian internet access market is forecast to generate total revenues of \$4.0bn in 2020, representing a compound annual rate of change (CARC) of -2.2% between 2016 and 2020.

Market consumption volume is forecast to increase with a compound annual growth rate (CAGR) of 0.7% between 2016 and 2020, to reach a total of 22.9 million subscriptions in 2020.

COVID-19 has led to greater reliance on internet use due to lockdowns and workplace closures, which have forced many people to work from home.
