KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The internet access industry within the NAFTA countries had a total market value of \$79,879.8 million in 2020.The Mexico was the fastest growing country, with a CAGR of 9% over the 2016-20 period.

Within the internet access industry, the US is the leading country among the NAFTA bloc, with market revenues of \$65,643.4 million in 2020. This was followed by Canada and Mexico, with a value of \$8,652.8 and \$5,583.5 million, respectively.

The US is expected to lead the internet access industry in the NAFTA bloc, with a value of \$78,755.5 million in 2025, followed by Canada and Mexico with



expected values of \$12,623.0 and \$9,295.9 million, respectively.
