SUMMARY

The Asia-Pacific investment banking & brokerage industry had total revenues of \$26.2bn in 2020, representing a compound annual growth rate (CAGR) of 16.2% between 2016 and 2020.

The bonds segment was the industry's most valuable in 2020, with total revenues of \$12.8bn, equivalent to 49.0% of the industry's overall value.

During the first half of the year, Investment banking activities benefitted from



high levels of industry-wide underwriting volumes, while industry-wide completed mergers and acquisitions volumes decreased, reflecting the impact of the COVID-19 pandemic on announcements in the first half of 2020.
