### SUMMARY

The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.

The Irish non-life insurance market had total gross written premiums of \$9.5 billion in 2022, representing a compound annual growth rate (CAGR) of 1% between 2017 and 2022.

The Motor segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$4.3 billion, equivalent to 45% of the market's

overall value.

Irish insurance clients' expenditures will rise in increased in 2022 due to inflation, which will also lead to higher claim expenses for non-life insurance companies.
