#### Summary

The Irish non-life insurance market had total gross written premiums of \$6.8 billion in 2022, representing a compound annual growth rate (CAGR) of 6.4% between 2017 and 2022.

The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$1.6 billion, equivalent to 23.7% of the market's overall value.

Non-life insurance coverage in the Irish population is relatively low. According to in-house research, in 2022, Ireland's non-life insurance penetration (ratio of premiums to GDP) stood at 1.6%.
