The Irish online retail market had total revenues of \$6,693.4m in 2021, representing a compound annual growth rate (CAGR) of 17.9% between 2017 and 2021.



Other Online Retail account for the largest proportion of sales in the Irish online retail market in 2021, sales through this channel generated \$3,618.9m, equivalent to 54.1% of the market's overall value.

Click-&-collect services are becoming widely available, which allows retailers to maximize retail potential without incurring delivery fees and give consumers almost immediate access to purchases without having to plan for deliveries.
