#### **KEY HIGHLIGHTS**

The G8 countries contributed \$745.1 million in 2019 to the global IT services industry, with a compound annual growth rate (CAGR) of 13.2% between 2015 and 2019. The G8 countries are expected to reach a value of \$1,337.0 million in 2024, with a CAGR of 12.4% over the 2019-24 period.

Among the G8 nations, the US is the leading country in the IT services industry, with market revenues of \$418.7 million in 2019. This was followed by Japan and Germany, with a value of \$91.6 and \$58.8 million, respectively.

The US is expected to lead the IT services industry in the G8 nations with a value of \$709.5 million in 2016, followed by Japan and Germany with expected



values of \$168.5 and \$118.0 million, respectively.
