#### **SUMMARY**

IT Services in Asia-Pacific industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). #### **KEY HIGHLIGHTS**

The IT services industry is valued as the combination of the business process outsourcing (BPO) services market, the application services market and the infrastructure services market. Values include revenues generated from (a) signed deals that remain under contract and (b) new contracts signed within that particular calendar year.

The Asia-Pacific IT services industry had total revenues of \$408.1bn in 2020, representing a compound annual growth rate (CAGR) of 10.1% between 2016 and 2020.

The infrastructure services segment was the industry's most lucrative in 2020, with total revenues of \$253.9bn, equivalent to 62.2% of the industry's overall value.



The IT services industry is highly correlated with the gross domestic product (GDP) of a country.
